Final Judgments

Record Verdict Obtained by Clifford Law Offices

Kevin P. Durkin and **Colin H. Dunn**, partners at Clifford Law Offices, obtained a \$22.7 million verdict on behalf of a widow and son whose young husband was killed in an accident four years ago.

A jury in the Cook County Circuit Court reached the record result in favor of Theresa Swenson, now 31, of Chicago following a two-week trial in the Daley Center before Judge Thomas Lipscomb. The verdict of \$10 million for grief and sorrow ties a previous record in Cook County set for that category, according to John Kirkton of the Jury Verdict Reporter. The jury also awarded \$10 million for loss of society. It is the largest wrongful death verdict in the county in more than a decade.

The case involved a speeding driver with drugs in his system who slammed into the back of Aaron Swenson's car stopped in a construction zone on Interstate 294 on May 22, 2012, crashing him into the vehicle in front of him.

In another case, **Bob Clifford** and **Shannon McNulty** settled a lawsuit filed against a local hospital for \$16.5 million. The case involved the successful heart transplant of a 70-year-old patient who was discharged to return home. The lawsuit alleged that at the time of discharge the defendant hospital negligently supplied erroneous medication instructions to the patient and his family, both verbally and in writing. Once home, the patient received the dosage of long-acting insulin as prescribed by the hospital, which was effectively a double-dose, resulting in a brain injury. The patient, a recently retired teacher, now requires 24-hour attendant care.

Keith Hebeisen and **Bradley Cosgrove** obtained a \$7.75 million verdict June 1 on behalf of the family of a 56-year-old man who died from cardiac issues following neurosurgery. The verdict was against the neurosurgeon who failed to recognize the Chicago man's previous heart issues and the physician failed to receive cardiac clearance from the appropriate doctors prior to the man's spinal surgery. **Susan Capra** worked on the case for eight years prior to the two-week trial before Judge Donald Suriano in the Daley Center.

Baby Powder Found to Cause Cancer in Women

Johnson & Johnson, the world's largest maker of health care products, was slammed with a \$72 million verdict by a Missouri jury for the death of an Alabama woman who died from ovarian cancer caused by the company's well-known baby powder and other products containing talcum.

The verdict, that was handed down Monday, February 22, 2016, is reported to be the first of among some 1,200 cases nationally involving this product and others that reportedly contain harmful ingredients. Since May, 2009, a coalition called the Campaign for Safe Cosmetics

began pushing Johnson & Johnson to eliminate questionable ingredients from its personal care products. After much negative publicity and a boycott threat by consumers, the company agreed in 2012 to eliminate the potentially carcinogenic ingredients 1,4–dioxane and formaldehyde, by last year. For some that has come too late.

For the 62-year-old Alabama mother who used the company's talcum powder for feminine hygiene for years, she died of ovarian cancer last year. Talc is mined from the soil and composed of magnesium, silicon, oxygen and hydrogen. Years ago, it was linked to asbestos.

After deliberating three hours, the jury decided the family was to get \$10 million in actual damages and \$62 million in punitive damages, meant to punish the corporation for its behavior. New Study Finds Third Leading Cause of Death in U.S. is Medical Error



The latest study on deaths in America indicates that the third leading cause is medical errors.

A professor of surgery at Johns Hopkins University School of Medicine is asking the Centers for Disease Control (CDC) to correct its records and list medical errors as the third most common cause of death in the United States with 251,454, following heart disease (614,348) and cancer (591,699). Dr. Martin Makary, a cancer surgeon and professor of health policy and management, examined four separate studies involving medical error from 2000–08 and found that more than a quarter of a million U.S. hospital patients die each year as a result of a medical error.

But the under-estimation of these numbers, according to Dr. Makary, is that the CDC does not allow physicians, medical examiners, coroners and funeral directors to list medical error as a the cause of death, he said in his letter to the CDC.

"The U.S. government and private sector spend a lot of money on heart disease, research and prevention. They also spend a lot of money on cancer research and prevention. It is time for the country to invest in medical quality and patient safety proportional to the mortality burdens it bears," he later wrote in a paper published in the British Medical Journal.

Medical errors cost taxpayers some \$4.4 billion each year, according to the Department of Health and Human Services' Inspector General.

Dr. Makary defined medical error from scientific literature as falling in one of four categories:

- An unintended act (either of omission or commission) or one that does not achieve its intended outcome.
- The failure of a planned action to be completed as intended (an error of execution).
- The use of a wrong plan to achieve an aim (an error of planning).
- A deviation from the process of care that may or may not cause harm to the patient." As Dr. Makary points out, hospitals are more interested in a medical coding system as to what caused a death in order to maximize billing for services. Hospitals are not interested in collecting accurate health statistics for purposes that may help the sick population.

So when someone dies from cancer that went undiagnosed, it would likely be coded as cancer, when in fact that patient may have been saved had a correct diagnosis been made in time. That means that the same mistake could happen again and again, with hospitals and health care providers ignoring the underlying problem.

Mass Victims Compensation Expert Hired by Volkswagen to Handle Rigged-Emissions Claims

Kenneth Feinberg, an attorney internationally recognized for working out payments to victims of the BP Gulf oil spill, General Motors ignition switch scandal, the 9/11 victims' compensation fund and other high-profile cases, has been hired by Volkswagen to work in a similar capacity to resolve thousands of lawsuits involving its emissions scandal.

The German automaker has said that Feinberg, 70, will design and administer an independent claims programs for owners of the affected diesel cars that have software designed to hoodwink the U.S. emissions testing system. About a half-million diesel cars in America are affected and several federal agencies are investigating the conduct of VW's executives over the past several years.

The move by VW to hire Feinberg has been considered by some to be a public relations idea as well as an alternative dispute resolution process meant to clear up many of the thousands of lawsuits filed by car owners against the company. Affected car owners are still allowed to pursue individual claims or class claims, should they choose, depending upon how they were impacted by the scam.

Feinberg is quoted as saying that his plan may include compensation for loss of gas mileage and buybacks. He also noted that if recall repairs were made, those car owners may mean giving up one's right to sue VW in order to obtain cash payments.

Experts have said that the repairs may not be a simple software change. They may include a hardware change that involves the exhaust system and a possible chemical treatment system that could affect the car's performance or gas mileage.

Lumber Liquidators Flooring Reportedly has Higher Cancer Risk than Initially Announced

People who bought certain kinds of flooring from Lumber Liquidators "are potentially at a greater risk of cancer than previously thought," according to a warning from the Centers for Disease Control (CDC), perhaps as much as three times higher.

The sale of certain types of laminate flooring has been halted and customers are being offered air quality tests.

The flooring in question is manufactured in China and reportedly has too high a concentration of formaldehyde levels causing as many as six to 30 cancer cases per 100,000 people, according to more recent CDC testing.

Marta Kowalczyk Davidson

The daughter of two physicians in Poland, Marta (Kowalczyk) Davidson immigrated to the United States when she was just three years old. Her father continued working as a board certified family practice physician in the U.S. and her mother worked in the health care field.

Marta has also taken part in settlement negotiations resulting in multi-million dollar settlements, including a \$2.75 million partial settlement in DeKalb County on behalf of the family of a 45-yearold man who died from medical malpractice and a \$2.55 million settlement, on behalf of a 54-yearold man who suffered severe and permanent injuries from negligent emergency room care. She currently handles a wide variety

of medical malpractice matters on surgical, cancer, cardiovascular, cardiology, orthopedic, obstetric and anesthesia cases in Cook County and the collar counties. She also handles other types of personal injury matters, including a case involving the drowning death of a six-year-old boy at a park district pool during day camp.

Marta attended the University of Illinois in Champaign-Urbana, majoring in political science and Spanish and it is where she met her husband, Philip. They were married last year with many of her relatives from Poland traveling to Park Ridge for the wedding. "It was very beautiful and, of course, memorable with so many of my family members able to share that day with us," Marta said. Her husband also is a lawyer and as newlyweds with intense jobs, much of their time since their August wedding has been devoted to their work and making a home in the southwest suburbs of Chicago.

Speaking fluent Polish, she has a large number of Polish clients given the large Polish population in Chicago. "Although language has never been a barrier for me, I empathize with people who have legal problems whose native language may not be English. I feel that I can better explain to them what may happen and what they can expect in seeking justice through the legal process. It is very heartwarming and satisfying as a career," she said.

Marta also considers herself fortunate to have some great teachers in her life. "I'm lucky to have a great number of mentors in my life – from Bob Clifford and Dr. Ken Chessick to Keith [Hebeisen], Brad [Cosgrove] and Susan [Capra] at the office," Marta says of the law partners at Clifford Law Offices on the medical malpractice team who have helped her since she arrived. "I see myself working here a long, long time."
